# **Ordinance No. 584-2022**

FOR PASSAGE June 6, 2022

### AN EMERGENCY ORDINANCE

Consenting and approving the issuance of a permit for the Hermes Hofbrauhaus Cleveland Half Marathon, 5K, and 10K, on August 7, 2022, managed by Hermes Sports & Events.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

#### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

<u>Section 1</u>. That pursuant to Section 411.06 of the Codified Ordinances of Cleveland, Ohio 1976, this Council consents to and approves the holding of the Hermes Hofbrauhaus Cleveland Half Marathon, 5K, and 10K, on August 7, 2022.

START on Chester Avenue before East 17th Street intersection; turn left onto East 18th Street; turn left onto Payne Avenue; turn left onto East 13th Street, US 322; turn right onto Chester Avenue, US 322l turn left onto East 101st Street; turn sharp right onto Mount Sinai Drive; turn left onto East 105th Street; turn left onto Martin Luther King, Jr. Drive; turn right onto East 105th Street; turn right onto Mount Sinai Drive; turn sharp left onto Ansel Road; turn left onto Chester Avenue, US 322; keep left onto Chester Avenue, US 322; FINISH on Chester Avenue past the East 17th Street intersection;

START on Chester Avenue before East 17th Street intersection; continue east on Chester Avenue; stay to the right when Chester Avenue splits; vear to the left and stay on Chester Avenue just before East 93rd Street intersection; turnaround on Chester Avenue just past East 93rd Street intersection and continue w; vear to the left and stay on Chester Avenue at East 93rd Street intersection and stay on Chester Avenue; FINISH on Chester Avenue after East 17th Street intersection;

START on Chester Avenue before East 17th Street intersection; continue east on Chester Avenue; stay to the right when Chester Avenue splits; turnaround on Chester Avenue before East 59th Street intersection and continue west; FINISH on Chester Avenue after East 17th Street intersection;

provided that the applicant sponsor shall meet all the requirements of Section 411.05 of the Codified Ordinances of Cleveland, Ohio, 1976. Streets may be closed as determined by the Chief of Police and safety forces as may be necessary in order to protect the participants in the event. Said permit shall further provide that the City of Cleveland shall be fully indemnified from any and all liability resulting from the issuance of the same, to the extent and in form satisfactory to the Director of Law.

<u>Section 2</u>. That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
