Request for Legislation

An ordinance to authorize the Department of Public Utilities to enter into one or more contracts to employ one or more professional consultants and/or vendors to provide professional services for the purpose of supplementing the regularly employed staff to manage billing systems and related systems and activities. Legislation is to lead to a contract or contracts for the term of one year with four one-year options to renew, the second of which requires additional legislative authority. Funds for the first year will be covered from the general operating funds from CWD and CPP; and, appropriations will be made annually from free balance for years 2, 3, 4 and 5.

Background/Purpose:

DPU utilizes consultants and vendors to manage many components of its billing systems and related activities. These components are listed below:

- Hosting services-These are services that provide the hardware for the billing system and other related software and the management of the operating system. Hosting is provided at a secure facility and includes a separate disaster recovery site.
- Managed Services-These are the day to day operations of the administration of the billing software and other related software. This also includes any special projects or initiatives requested by DPU.
- Bill Print and Mail-Printing and mailing of bills and letters to customers.
- Electronic Bill Payment and Presentment-Processing of electronic bill payments, hosting of bill payment site, storing and presenting of bills electronically.
- Software-Various software is needed to manage the billing system including billing, code management, compiling, project management, encryption, scheduling, reporting, and cashiering.

DPU will need to competitively bid many of these components as their contracts come to an end. DPU requires new contracts to be in place prior to the expiration of the existing contract so as not to disrupt billing operations.

Scope of Work/Commodities/Services:

To enter into multiple contracts to provide, hosting, cloud computing, managed services, bill and letter printing and mailing, electronic bill payment and presentment, and any other related services needed to manage DPU billing and related functions.

Justification/Urgency:

These contracts will need to be in place before the end of 2022 prior to the contracts expiring in early to mid-2023.

Anticipated Costs and funding source:

Funds for the first year will be covered from the general operating funds from CWD and CPP; and, appropriations will be made annually from free balance for years 2, 3, 4 and 5.
