# Ordinance No. 643-2022

<u>AN EMERGENCY ORDINANCE</u> Consenting and approving the issuance of a permit for the annual Fox 8 Fox Trot event, on August 28, 2022, managed by Hermes Sports & Events.

## <u>FOR PASSAGE</u> July 13, 2022

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

<u>Section 1.</u> That pursuant to Section 411.06 of the Codified Ordinances of Cleveland, Ohio 1976, this Council consents to and approves the holding of the annual Fox 8 Fox Trot event, on August 28, 2022, managed by Hermes Sports & Events.

**1 Mile Course**: Start on Superior Avenue at Public Square; head west on Superior Avenue; turn left on West Huron Road; turn left on Ontario Street; turn left on South Roadway; Finish on Superior Avenue at Public Square.

**5K Course**: Start on Superior Avenue at Public Square; head west on Superior Avenue; turn right on West 3<sup>rd</sup> Street; turn right on Al Lerner Way; turn right on East 9<sup>th</sup> Street; turn left on Euclid Avenue; turn right on East 14<sup>th</sup> Street; turn right on Carnegie Avenue; turn right on Ontario Street; turn left on South Roadway; Finish on Superior Avenue at Public Square.

The applicant sponsor shall meet all the requirements of Section 411.05 of the Codified Ordinances of Cleveland, Ohio, 1976. Streets may be closed as determined by the Chief of Police and safety forces as may be necessary in order to protect the participants in the event. Said permit shall further provide that the City of Cleveland shall be fully indemnified from any and all liability resulting from the issuance of the same, to the extent and in form satisfactory to the Director of Law.

<u>Section 2.</u> That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
