FOR PASSAGE July 13, 2022

AN EMERGENCY ORDINANCE

Consenting and approving the issuance of a permit for the annual Pat Joyce 5K Event, on July 30, 2022, managed by Hermes Sports & Events.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

That pursuant to Section 411.06 of the Codified Ordinances of Cleveland, Ohio 1976, this Council consents to and approves the holding of the annual Pat Joyce 5K Event, on July 30, 2022, managed by Hermes Sports & Events. Start on Albers Avenue and turn right on Rocky River Drive; turn left on Amber Drive and go to end and turn around; turn right on Rocky River Drive; turn left on Claire Avenue and follow around as it turns into Marquis Avenue; turn left on Rocky River Drive; turn left on West Park Road; turn right on West 159th Street; turn right on Lucille Avenue; turn left on West 165th Street; turn right on Dartmouth Avenue; turn left on West 169th Street; turn left on Ferndale Avenue; turn right on West 165th Street; turn right on Lorain Avenue; turn left on West 168th Street; turn right on Albers to finish; provided that the applicant sponsor shall meet all the requirements of Section 411.05 of the Codified Ordinances of Cleveland, Ohio, 1976. Streets may be closed as determined by the Chief of Police and safety forces as may be necessary in order to protect the participants in the event. Said permit shall further provide that the City of Cleveland shall be fully indemnified from any and all liability resulting from the issuance of the same, to the extent and in form satisfactory to the Director of Law.

<u>Section 2.</u> That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
