Ordinance. No. <u>610-2022</u>

Request for Legislation

An ordinance authorizing the Division of Water to enter into public improvement contracts to renew, repairing, and replacing various water mains, including but not limited to, cleaning, lining, and structural lining, in the City of Cleveland for the years 2023 and 2024.

Background/Purpose:

Distribution mains (16" in diameter and smaller) are the secondary arteries of the Cleveland water system, and approximately 1300 miles exist in the city proper. The average age of water mains in the CWD system is 67 years, and several mains are 100 years old or older. Aging water mains can experience a number of problems, including excessive main breaks with resulting disruption of service, lower flows for firefighting, and discolored water incidents. Renewing the stock of mains in the city is an appropriate reinvestment in the distribution system.

Scope of Work/Commodities/Services:

CWD currently renews via Public Improvement contracts approximately \$5 Million dollars' worth of water mains annually. Several years ago the Division shifted its focus away from main cleaning and lining to full replacement, but occasionally performs lining (structural, semi-structural, non-structural) where appropriate (e.g. under railroad tracks.) When water mains are replaced, old lead service connections are replaced with copper connections. On most streets, CWD works with the Mayor's Office of Capital Projects (MOCAP) to ensure the final wearing surface of the street is repaved curb to curb. (Separately, as another means of main renewal, when MOCAP is performing its own street rebuild project, CWD will often agree to reimburse MOCAP to replace water mains on those streets when appropriate.)

This legislation would authorize the Division of Water to enter into Public Improvement Contracts to renew, repair, and replace water mains, and to line them when more appropriate. Earlier this year CWD sent to Council its 5-year list of anticipated water main renewal work.

Justification/Urgency:

Renewing water mains in the city is a necessary ongoing reinvestment in the distribution system.

Anticipated Costs and funding source:

The cost of these projects is estimated to be \$10 Million over the two years. Although this ordinance will authorize both years of work, we are initially just funding the 1st year at \$5 Million. For the following year we will process a budget adjustment to add the 2nd year of funding.

The cost of the improvement and other expenditures authorized shall be paid from Fund 52, SF 001, from the fund or sub fund to which are credited the proceeds of future bonds, if issued for this purpose and/or that the Director of Public Utilities and/or the Director of Finance is authorized to apply for and accept one or more Water Supply Revolving Loan Account ("WSRLA") loans from the Ohio Water Development Authority to provide partial financing for the improvement..

Schedule or Term of Contract:

These Public Improvements shall be for the Years 2023 and 2024.
