- Opportunity of a lifetime posted to be Director of Public Health on April 20th – accepted job on May 24th





- Improve health of community (not clinical/patient-oriented)
- Demonstrate positive health impact in 5 yrs or less & cost effectiveness & savings over time

Address the Social Determinants of Health

The most impactful – Tobacco Use

- Cleveland's smoking rate: 30% of all adults (worst in the country)
- USA average smoking rate: 12.5%
- Tobacco Use is the leading preventable cause of death in the United States.
- One in five deaths are attributed to cigarettes.
- Life expectancy for smokers is at least 10 years shorter than for non-smokers.
- Quitting before the age of 40 reduces the risk of dying from smoking-related disease by 90%.

The most impactful – Black Infant Mortality

- Black infant mortality rate in Cleveland 14.6 per 1000 compared to 2 per 1000 White infant mortality.

The most impactful – Lead Poisoning

- Lead poisoning rate is 12.5% (Lead > 5ug/dL) in Cleveland children – the number should be 0%.

The most impactful – Gun Violence

- Gunshot wound hospital visits nearly doubled from 2019 (91.9 per 100,000) to 2021 (157.5 per 100,000)



The most impactful – Traffic Fatalities

- 74 traffic-related deaths in 2021, 31 as of 8/8/22 in 2022. The Vision is ZERO.

The most impactful – Opioid Overdose Deaths

- Cleveland had 72.5 deaths per 100K population from opioids, compared to 37.8 per 100K in Cuyahoga, 14.5 per 100K in USA.

The most impactful –

- Air pollution, Food safety, Diabetes, Obesity, Mental Health, Maternal Health, Access to Health care, Access to Green space, Access to Healthy Food, Poverty, Systemic Racism

MONKEYPOX IS AN INFECTION CAUSED BY A VIRUS IN THE SAME FAMILY AS SMALLPOX. IT HAS BEEN AROUND FOR MORE THAN HALF A CENTURY.



TRANSMISSION

Monkeypox is spread through:

- Direct physical contact with sores, rash, scabs, or body fluids from a person with monkeypox
- Touching objects, fabrics (clothing, bedding, or towels), and surfaces that have been used by someone with monkeypox
- Contact with respiratory secretions during prolonged, face-to-face contact.

The purpose of the COVID-19 Watch is to summarize the coronavirus surveillance in the City of Cleveland, Ohio. This summary report reflects the period starting from February 15, 2020 until July 30, 2022.

What Matters Most

1. Cleveland COVID-19 cases increased during the week of July 24th with 812 new cases and a rate of 212 new cases per 100,000 residents. The true number of cases is likely much greater than is reported here, due to the fact that positive home tests are not being reported to the health department. If you test positive for COVID-19 using an at-home test kit, please report the result to the Cleveland
