#### Ord. No. 770-2022

By Council Members McCormack and Griffin (by departmental request)

An emergency ordinance authorizing the purchase or rental by one or more requirement contracts of the purchase or rental of new heating, ventilation, and air conditioning systems, and the necessary items of labor, equipment, and materials necessary to maintain, repair, test, inspect, or enhance existing systems, for the Division of Airports, Department of Port Control for a term of two years, with two one-year options to renew, the first of which shall require additional legislative authority.

#### Res. No. 954-2022

An emergency resolution establishing a working committee of Council, the Administration, and community stakeholders to study Community Benefits Agreement policies and ordinances, and consider implementing a City policy and ordinance to ensure that development projects provide maximized, tangible benefits to Cleveland's communities and citizens; and improve reporting practices and public accessibility to workforce and community benefits data and information.
