AN EMERGENCY ORDINANCE

Authorizing the Director of Public Safety to apply for and accept a grant from the Ohio Office of Criminal Justice Services for the FY 22 ARPA Violent Crime Reduction Grant to fund Violence Interrupters, Crime Gun Intelligence Center and Violent Crime Reduction Teams; authorizing the Director to enter into one or more contracts with Case Western Reserve University; and authorizing the Director of Public Safety, or appropriate director, to enter into various contracts needed to implement the grant.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Public Safety is authorized to apply for and accept a grant in the approximate amount of \$1,752,601.01, and any other funds that may become available during the grant term from the Ohio Office of Criminal Justice Services for the FY 22 ARPA Violent Crime Reduction Grant to fund Violence Interrupters, Crime Gun Intelligence Center and Violent Crime Reduction Teams; that the Director is authorized to file all papers and execute all documents necessary to receive the funds under the grant; and that the funds are appropriated for the purposes described in the title page and expense sheets for the grant contained in the file described below.

<u>Section 2.</u> That the title page and expense sheets for the grant, **File No. 1149-2022-A**, made a part of this ordinance as if fully rewritten, is approved in all respects and shall not be changed without additional legislative authority.

<u>Section 3.</u> That the Director of Public Safety is authorized to extend the term of the grant during the grant term.

Section 4. That the Director of Public Safety is authorized to make one or more written standard purchase contracts and written requirement contracts under the Charter and the Codified Ordinances of Cleveland, Ohio, 1976, the period of requirements to be determined by the director, for the necessary items of one National Integrated Ballistic Information Network machine ("NIBIN"), one ballistics test fire tank and laptop computers to maintain records and access social service program partners, to be purchased by the Commissioner of Purchases and Supplies on a unit basis for the Department of Public Safety. Bids shall be taken in a manner that permits an award to be made for all items as a single contract, or by separate contract for each or any combination of the items as the Board of Control determines.

<u>Section 5.</u> That under Section 108(b) of the Charter, the purchases authorized by this ordinance may be made through cooperative arrangements with other governmental agencies. The Director of Public Safety may sign all documents that are necessary to make the purchases, and may enter into one or more contracts with the vendors selected through that cooperative process.

Section 6. That the costs of the standard and requirement contract or contracts shall be charged against the proper appropriation accounts and the Director of Finance shall certify the amount of any purchase under the contracts, each of which purchases shall be made on order of the Commissioner of Purchases and Supplies by a delivery order issued against the contract or contracts and certified by the Director of Finance.

<u>Section 7.</u> That the Director of Public Safety is authorized to enter into one or more contracts with Case Western Reserve University to implement the grant as described in the file, payable from the fund or funds to which are credited the proceeds of the grant accepted in this ordinance.

Section 8. That the Director of Public Safety or Community Relations Board is authorized to employ by contract or contracts one or more consultants or one or more firms of consultants for the purpose of supplementing the regularly employed staff of the several departments of the City of Cleveland in order to provide Violence Interrupter services needed to implement the grant as described in the file.

The selection of the consultant or consultants for the services shall be made by the Board of Control on the nomination of the Director of Public Safety or Community Relations Board from a list of qualified consultants available for employment as may be determined after a full and complete canvass by the Director of Public Safety or

Community Relations Board for the purpose of compiling a list. The compensation to be paid for the services shall be fixed by the Board of Control. The contract or contracts authorized shall be prepared by the Director of Law, approved by the Director of Public Safety or Community Relations Board, and certified by the Director of Finance. The cost of the contract or contracts authorized shall be paid from the fund or funds to which are credited the proceeds of the grant accepted in this ordinance.

Section 9. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
