Section 1. That the Director of City Planning is authorized to enter into an amendment ("Amendment") to Contract No. PS 2019-138, as amended, with Code Studio, Inc. to extend the term through June 30, 2023, to provide additional engagement activities for the Form-Based Zoning pilot initiative and for review of draft code elements.

All other terms and conditions contained in Contract No. PS 2019-138, as amended, shall remain the same.

Section 2. That the Amendment shall be prepared by the Director of Law.

Section 3. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
