<u>AN EMERGENCY ORDINANCE</u> Consenting and approving the issuance of a permit for the Ascend Fitness 5K Run on July 15, 2023, managed by Hermes Sports & Events.

## <u>FOR PASSAGE</u> <u>November 28, 2022</u>

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

<u>Section 1.</u> That pursuant to Section 411.06 of the Codified Ordinances of Cleveland, Ohio 1976, this Council consents to and approves the holding of the Ascend Fitness 5K Run on July 15, 2023, managed by Hermes Sports & Events; Start: St. Clair Avenue at Key Tower; head west to West 9<sup>th</sup> Street; turn right on West 9<sup>th</sup> Street to Lakeside Avenue; turn right on Lakeside Avenue and left on West 3<sup>rd</sup> Street; turn right on Al Lerner Way to East 9<sup>th</sup> Street; turn right on East 9<sup>th</sup> Street to Lakeside Avenue; turn left on Lakeside Avenue to East 18<sup>th</sup> Street; turn right on East 18<sup>th</sup> Street to St. Clair Avenue; turn right on St. Clair Avenue to Finish at the Start Line; provided that the applicant sponsor shall meet all the requirements of Section 411.05 of the Codified Ordinances of Cleveland, Ohio, 1976. Streets may be closed as determined by the Chief of Police and safety forces as may be necessary in order to protect the participants in the event. Said permit shall further provide that the City of Cleveland shall be fully indemnified from any and all liability resulting from the issuance of the same, to the extent and in form satisfactory to the Director of Law.

<u>Section 2.</u> That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
