## AN EMERGENCY ORDINANCE

Consenting and approving the issuance of a permit for The 5<sup>th</sup> Annual Cleveland Kurentovanje Kurent Dash, February 18, 2023, managed by Hermes Sports & Events.

## FOR PASSAGE January 23, 2023

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That pursuant to Section 411.06 of the Codified Ordinances of Cleveland, Ohio 1976, this Council consents to and approves the holding of The 5<sup>th</sup> Annual Cleveland Kurentovanje Kurent Dash, February 18, 2023, managed by Hermes Sports & Events; START on Lausche Avenue at St. Vitus Church; turn left on East 61<sup>st</sup> Street; turn right on Carry Avenue; turn left on East 55<sup>th</sup> Street; turn right on Hamilton Avenue; TURNAROUND on Hamilton Avenue just past East 33<sup>rd</sup> Street; turn left on East 55<sup>th</sup> Street; turn right on Carry Avenue; turn left on East 61<sup>st</sup> Street; turn left an East 55<sup>th</sup> Street; turn left on East 55<sup>th</sup> Street; turn left and East 55<sup>th</sup> Street; turn left and East 55<sup>th</sup> Street; turn left and East 61<sup>st</sup> Street; turn left and East 55<sup>th</sup> Street; turn left and East 55<sup>th</sup> Street; turn left and East 61<sup>st</sup> Street; turn left and East 61<sup>st</sup> Street; finish on Lausche Avenue; turn left on East 61<sup>st</sup> Street; turn left applicant sponsor shall meet all the requirements of Section 411.05 of the Codified Ordinances of Cleveland, Ohio, 1976. Streets may be closed as determined by the Chief of Police and safety forces as may be necessary in order to protect the participants in the event. Said permit shall further provide that the City of Cleveland shall be fully indemnified from any and all liability resulting from the issuance of the same, to the extent and in form satisfactory to the Director of Law.

<u>Section 2.</u> That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
