#### **Ord. No. 52-2023**

By Council Members Santana and Griffin (by departmental request)

An emergency ordinance authorizing the Director of Finance to enter into an agreement with College Now Greater Cleveland, Inc., as fiscal agent to Say Yes Cleveland, for family support specialist services for students attending to the Cleveland Metropolitan School District and its partner schools in Cleveland, for a period of approximately four months.

#### **Ord. No. 94-2023**

An emergency ordinance directing a portion of the City's Coronavirus Local Fiscal Recovery Fund payment to respond to the public health emergency or its negative economic impacts by providing services to address educational disparities in disproportionately impacted communities, and authorizing the Director of Finance to enter into agreements with The Cleveland Foundation for same, in an amount not to exceed \$3,746,000, to be encumbered March 3, 2021, and ending December 31, 2024.
