## Ord. No. 91-2023

An emergency ordinance directing a portion of the City's Coronavirus Local Fiscal Recovery Fund payment to respond to the public health emergency or its negative economic impacts through the support of a citywide program designed to assist City residents who want and are available for work, and to assist said City residents with accessing public benefits, and authorizing agreements with College Now Greater Cleveland, Inc., for same, for an amount not to exceed \$300,000, to be encumbered March 3, 2021, and ending December 31, 2024.

Estimated Cost: \$300,000

## Ord. No. 94-2023

An emergency ordinance directing a portion of the City's Coronavirus Local Fiscal Recovery Fund payment to respond to the public health emergency or its negative economic impacts by providing services to address educational disparities in disproportionately impacted communities, and authorizing the Director of Finance to enter into agreements with The Cleveland Foundation for same, in an amount not to exceed \$3,746,000, to be encumbered March 3, 2021, and ending December 31, 2024.
