AN EMERGENCY ORDINANCE

Authorizing the Director of Port Control to enter into an amendment to Contract No. PS2018-059 with Recess Creative, LLC to provide additional marketing, promotional, public relations, advertising and creative services to promote Cleveland Hopkins International and Burke Lakefront Airports, for a period not to exceed six months, on a month-to-month basis.

WHEREAS, under the authority of Ordinance No. 730-17, passed July 12, 2017, and Board of Control Resolution No. 619-17, adopted December 13, 2017, the Director of Port Control entered into Contract No. PS2018-059 with Recess Creative, LLC to provide marketing, promotional, public relations, advertising and creative services to promote Cleveland Hopkins International and Burke Lakefront Airports; and

WHEREAS, the City desires to extend the term of the contract for a period not to exceed six months, on a month-to-month basis; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Port Control is authorized to enter into an amendment to Contract No. PS2018-059 with Recess Creative LLC to extend the term for a period not to exceed six months, on a month-to-month basis, to provide additional marketing, promotional, public relations, advertising and creative services to promote Cleveland Hopkins International and Burke Lakefront Airports. All other terms and conditions of Contract No. PS2018-059 will remain the same.

Section 2. That the cost of the amendment shall be paid from Fund Nos. 60 SF 001 and 60 SF 141. (RQS 3001, RL 2023-3)

Section 23. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
