Ordinance No: 32-2023

Program Name: OCJS – Pretrial Services Grant Funding 2022-2024

Description: The Cleveland Municipal Court will use the funds to expand staffing in Pretrial Service Department and purchase equipment necessary for the courtrooms/offices to assist with ensuring cases that are eligible for pretrial services are disposed of quickly. The goal is to minimize and reduce the backlog of cases and increase referrals for defendants to attend treatment/assistance/recovery services as an alternative to jail.

Grant Period: Beginning October 1, 2022 through September 30, 2024




