## AN EMERGENCY ORDINANCE

~~Authorizing the Director of Public Works to employ one or more professional consultants to assess, recommend, and procure property insurance for the City of Cleveland-owned stadium located at 100 Alfred Lerner Way, and other related services; for a period up to two years.~~

An Emergency Ordinance authorizing the purchase by one or more contracts of property insurance for the City of Cleveland-owned stadium located at 100 Alfred Lerner Way, for the Department of Public Works, for a period up to two years.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

~~Section 1.—That the Director of Public Works is authorized to employ by contract or contracts one or more consultants or one or more firms of consultants for the purpose of supplementing the regularly employed staff of the several departments of the City of Cleveland in order to provide professional services necessary to assess, recommend, and procure property insurance for the City of Cleveland-owned stadium located at 100 Alfred Lerner Way, and other related services, for a period up to two years.~~

~~—The selection of the consultants or firms of consultants for the services shall be made by the Board of Control on the nomination of the Director of Public Works from a list of qualified consultants available for employment as may be determined after a full and complete canvass by the Director of Public Works for the purpose of compiling a list. The compensation to be paid for the services shall be fixed by the Board of Control and may include the cost of the insurance premium, loss control services and other costs incurred by the consultant on the City's behalf. The contract or contracts authorized shall be prepared by the Director of Law, approved by the Director of Public Works, and certified by the Director of Finance.~~

Section 1. That the Director of Public Works is authorized to make one or more written contracts under the Charter and the Codified Ordinances of Cleveland, Ohio, 1976, for each or all of the following items: property insurance for the City of Cleveland-owned stadium located at 100 Alfred Lerner Way for a gross price for the Department of Public Works, for a period up to two years.

Section 2. That under Section 108(b) of the Charter, the purchases authorized by this ordinance may be made through cooperative arrangements with other governmental agencies. The Director of Public Works may sign all documents that are necessary to make the purchases, and may enter into one or more contracts with the vendors selected through that cooperative process.

Section-2 3. That the cost of the contract or contracts authorized shall be paid from Fund No. 11 SF 600. (RQS 7005, RLA 2022-75)

Section-3 4. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
