WHEREAS, this Council wishes to withdraw its objection to the above transfer and consents to said transfer; and

## BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That objection to a C1, C2 and D6 Liquor Permit to Speedway, LLC, DBA Speedway, #8641, 4280 West 150th Street and I-71, Cleveland, Ohio 44135, Permit No. 84189940300, be and the same is hereby withdrawn and Resolution No. 21-2022, containing such objection, be and the same is hereby repealed and that this Council consents to the immediate transfer thereof.

<u>Section 2</u>. That this resolution is hereby declared to be an emergency measure and provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its adoption and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
