WHEREAS, this Council objected to the transfer of location of a D2, D2X, D3 and D3A Liquor Permit to La Vida, Inc., DBA Steelyard Tavern, 4317 State Road, Cleveland, Ohio 44109, Permanent No. 4957324-0001 by Resolution No. 589-2022 adopted June 6, 2022 and by Resolution No. 822-2022 adopted August 10, 2022; and

WHEREAS, this Council wishes to withdraw its objections to the above permit and consents to said permit; and

WHEREAS, this resolution constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That objection to the transfer of location of a D2, D2X, D3 and D3A Liquor Permit to La Vida, Inc., DBA Steelyard Tavern, 4317 State Road, Cleveland, Ohio 44109, Permanent No. 4957324-0001, be and the same is hereby withdrawn and Resolution Nos. 589-2022 and 822-2022, containing such objections, be and the same is hereby repealed and that this Council consents to the immediate permit thereof.

Section 2. That this resolution is hereby declared to be an emergency measure and provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its adoption and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
