WHEREAS, this Council objected to the transfer of location of a D1, D2, D3, D3A and D6 Liquor Permit to Ankor Restaurant & Ultra Lounge, LLC, DBA Ankor Restaurant & Lounge, 1030 East 152nd Street, Cleveland, Ohio 44110, Permit No. 02855570001 by Resolution No. 1239-2022 adopted by the Council on November 21, 2022; and

WHEREAS, this Council wishes to withdraw its objection to the above permit and consents to said permit; and

WHEREAS, this resolution constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

#### BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That objection to the transfer of location of a D1, D2, D3, D3A and D6 Liquor Permit to Ankor Restaurant & Ultra Lounge, LLC, DBA Ankor Restaurant & Lounge, 1030 East 152nd Street, Cleveland, Ohio 44110, Permit No. 02855570001, be and the same is hereby withdrawn and Resolution No. 1239-2022, containing such objection, be and the same is hereby repealed and that this Council consents to the immediate permit thereof.

Section 2. That this resolution is hereby declared to be an emergency measure and provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its adoption and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
