BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

<u>Section 1</u>. That there is hereby appropriated the additional revenue from the American Rescue Plan Act lost revenue calculation that was applied to eligible General Expenditures as set forth in the Amended Official Certificate of Estimated Resources previously unappropriated as follows:

<u>Section 2</u>. That the Director of Finance is authorized to transfer the amount appropriated in Section 1 of this ordinance to the Strategic Priority Subfund.

<u>Section 3</u>. That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
