Request for Legislation

An ordinance to allow the Department of Public Utilities to enter into one or more requirement contracts for testing, maintaining, installing, repairing, and replacing landscaping at all Department of Public Utilities' facilities and in rights of way, for a two-year term.

Background/Purpose:

The Department of Public Utilities has several facilities, including office buildings, water filtration plants, pump stations, sewer lift stations, electrical service centers and sub-stations, yards, and towers that require landscaping services. Testing, maintaining, refurbishing and repairing landscaping are needed to preserve a positive aesthetic appearance at the properties. Additionally, the same services may be needed to repair landscaping in rights of way where underground facilities have been repaired.

The Department of Public Utilities is requesting legislation to authorize the purchase of services for a twoyear period. This ordinance will allow for the execution of new requirement contracts for these services.

Scope of Work/Commodities/Services:

The scope of work includes, but is not limited to, turf areas, trees, shrubs, ground cover, tree trimming, rain gardens, bioswales and lawns at facilities and in rights of way. It will provide general maintenance and trash/litter management.

Generally such work includes:

- Seasonal, special and general cleanup, including hillside/brush removal and maintenance.
- Irrigation monitoring and watering.
- Soils testing and preparation; ph & nutrient adjustment; weed, disease, & insect control; pathology testing.
- Mulching/cultivating, aerating, thatching, pruning, tree trimming, lawn/field mowing, edging/trimming, planting of new plants, shrubs and trees.
- Install, replace, and restore tree lawns damaged due to utility work performed by the Department of Public Utilities.
- Maintaining, repairing and installing rain gardens and bioswales which improve water quality by reducing surface runoff of pollutants and contaminants.

Justification/Urgency:

The aesthetic appearance of the Department of Public Utilities' facilities is critical to the image of the systems that provide electricity, remove sewage and produce drinking water for the health and welfare of the City and neighboring communities. When landscaping components are not maintained, replaced or refurbished, the Department of Public Utilities ability to provide drinking water, deliver electricity and/or remove sewage becomes impaired and its public image tarnished.

Anticipated Costs and funding source:

This requirement contract is estimated to cost \$1,200,000 over its life. Operating or Capital Funds will be used.

First year: \$600,000. Second Year: \$600,000.

Schedule or Term of Contract:

Legislation is to lead to a requirement contract or contracts for the term of two years.
