Ord. No. 482-2023

By Council Members Jones, Bishop, Gray, Hairston and Griffin (by departmental request)

An emergency ordinance authorizing the Director of Economic Development to enter into, or cause to be entered into, one or more agreements to provide economic development assistance for commercial corridor projects in Cleveland's Southeast Side neighborhoods and other agreements; and authorizing the Director to apply for and accept any gifts, grants or services from any public or private entity.

Estimated Cost: \$5,000,000
