Request for Legislation

Authorizing the Director of the Department of Public Utilities to enter into one or more requirement contracts for the purchase of labor and materials necessary to repair and maintain the decorative and special lighting for City bridges and the Wyland Whale Mural Park on North Marginal Road, including materials, equipment, appurtenances, services and insurance, for the division of Cleveland Public Power, Department of Public Utilities for a period of two (2) years.

Background/Purpose:

This legislation will authorize CPP to enter into a contract or contracts for the labor and materials needed to maintain the decorative and special lighting for the following Flats-area bridges: Main Avenue, Willow Street, Center Street, Eagle Avenue, Bascule Bridges #1 and #2 and the Conrail Bridge, as well as other city bridges if needed. The contract also includes repairs and maintenance on the lighting at the Wyland Whale Mural Park on North Marginal.

Scope of Work:

The contractor or contractors will provide all labor, materials, equipment, appurtenances, services and, insurance necessary to maintain the decorative lighting on city bridges and any special lighting as directed for approximately 500 light fixtures, along with the Wyland Whale Mural Park on North Marginal Road. Services include cleaning of lenses and reflectors and repair or replacement of lamps, lenses, ballasts, service breakers, timers, conduits, conductors, sensors, controls and associated fixtures, and the repairing of low voltage supply equipment

Justification/Urgency:

The decorative and special lighting on these bridges must be maintained on a regular basis.

Anticipated Costs and funding source:

The projected estimate for this contract is \$500,000.00. The General Operating budget will be used for this contract.

Schedule or Term of Contract:

This legislation will lead to one or more requirement contracts for a term of two years.
