# Wellness and fitness programs

## **Cancer Screening Physical**

### DESCRIPTION

We seek AFG funding to put our members through a comprehensive cancer screening. Cleveland, Ohio has some of the world's leading hospital systems. The Division plans to partner with them for cancer screenings. The last cancer screening test was conducted in 2018. The test included screening for thyroid, liver, gall bladder, kidney, pancreas, testicular, and other cancers. The Division had an 82% participation rate (607 out of 742). From this screening, several of the Division's members' lives were saved by finding cancer early. The Division will maintain a cancer screening process on a schedule the doctor recommends. The Division's goal is that this program will serve as a beacon for all the northeast Ohio fire departments. With our findings, the Division will work with regional partners to help the region improve its health and wellness. With this grant funding, and implementation of the program, the Division forecasts a high participation rate. We will go out for competitive bidding for this contract, but we estimate approximately 658 participants (85% of the firefighters) X \$402.74 per participant.

## Behavioral Health NFPA 1500 or equivalent

#### DESCRIPTION

We request AFG funding for a comprehensive behavioral health screening from a local behavioral health research doctor. The screening is projected to reach around 500 people. The division estimates forty percent of the workforce will partake in this (774 \*.40 = 309). This will give the Cleveland Division of Fire and surrounding Fire departments a good foundational synopsis of what their member's behavioral needs are. After the assessments, we seek AFG funding to provide participants (identified) confidential treatment for conditions. That cost is on a separate line item in this proposal. The Division will define its ongoing Health and Wellness program, from this data, to target the issues presented. The research department will conduct a study and provide the Cleveland Division of Fire with best practices to promote and sustain the department's behavioral health and be available for regional partners to learn from. The Division also aims to have protocols put in place for a more meaningful way of supporting the Division's members. The budget is based on a cost of \$200 per person X 500 people. We will go out for competitive bidding for this contract.

The Cleveland Division of Fire is seeking funds for our annual medical and fitness evaluations and expanding behavioral health and cancer screenings. Every member of the Division goes through an extensive medical exam as part of the hiring process. The exam consists of physical exams, hearing tests, and mental health evaluations. After the initial exam, no other exams are done regularly. The yearly medical and fitness evaluations will be designed to meet NFPA 1583 standards. After the initial Assistance to Firefighter Grant (AFG) funding, the city will maintain the cost of the annual physicals and fitness exams.
