<u>Section 1</u>. That objection to the transfer of ownership of a D5 and D6 Liquor Permit to New Seven Entertainers Lounge, LLC, 14804 St. Clair Avenue, Cleveland, Ohio 44110, Permit No. 6367889 by Resolution No. 142-2024, containing such objection, be and the same is hereby repealed and that this Council consents to the immediate permit thereof.

<u>Section 2</u>. That this resolution is hereby declared to be an emergency measure and provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its adoption and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
