## **Ordinance No. 413-2024**

#### AN EMERGENCY ORDINANCE

To supplement the Codified Ordinances of Cleveland, Ohio, 1976, by enacting new Section 143.06 relating to applications for and acceptance of grants and other funding and services from any public or private entity to place fellows and interns in various City departments.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

#### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Codified Ordinances of Cleveland, Ohio, 1976, are supplemented by enacting new Section 143.06 to read as follows:

<u>Section 143.06</u> <u>Applications for and Acceptance of Fellowship and</u> <u>Intern Grants and other Funding and Services from any Public or Private Entity</u>

- (a) The Director of Human Resources or other appropriate Director, is authorized to apply for and accept grants and other funding and services from any public or private entity for programs to place fellows and interns in various City departments. The appropriate director is authorized to file all papers, execute all documents, and enter into any agreements necessary to apply for, accept, and/or receive the funds or services. Any funds received shall be appropriated for the purposes described in this section.
- (b) The appropriate Director is further authorized to pay cash matching funds if required to receive grant funding. The matching funding shall be paid from funds appropriated for the use of the applicable City department.

Section 2. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
