# **Ordinance No. 473-2024**

## **By Council Member Gray**

### AN EMERGENCY ORDINANCE

Designating Second New Hope Baptist Church (former St. Margaret of Hungary Catholic Church) as a Cleveland Landmark.

WHEREAS, under Chapter 161 of the Codified Ordinances of Cleveland, Ohio, 1976, the Cleveland Landmarks Commission (the "Commission"), has proposed to designate Second New Hope Baptist Church (former St. Margaret of Hungary Catholic Church) as a landmark; and

WHEREAS, the owner of Second New Hope Baptist Church has been properly notified and has consented in writing to the proposed designation; and

WHEREAS, the Commission has recommended designation of Second New Hope Baptist Church as a landmark and has set forth certain findings of fact constituting the basis for its decision; and

WHEREAS, this ordinance constitutes an emergency measure providing for the immediate preservation of the public peace, property, health, and safety in that the immediate protection of the historic landmark is necessary to safeguard the special historical, community, or aesthetic interest or value in the landmark; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That Second New Hope Baptist Church (former St. Margaret of Hungary Catholic Church) whose street address in the City of Cleveland is 2917 East 116<sup>th</sup> Street, Cuyahoga County Auditor's Permanent Parcel Number is 129-18-080, and is also known as the following described property:

Situated in the City of Cleveland, County of Cuyahoga and State of Ohio, and known as being the Southerly 30 feet of Sublot No. 8 and all of Sublot Nos. 9 through 15 inclusive and 27 and 28 in the Rice Homestead Allotment of part of Original One Hundred Acre Township Lot No. 428 as shown by the recorded plat in Volume 45 of Maps, Page 12 of Cuyahoga County Records, together forming a parcel of land having a frontage of 275 feet on the Easterly side of East 116<sup>th</sup> Street, be the same more or less, but subject to all legal highways.

Legal Description approved by Eric Westfall, Section Chief, Plats, Surveys and House Numbering Section

which in its entirety is a property having special character or special historical or aesthetic value as part of the development, heritage, or cultural characteristics of the City, State, or the United States, is designated a landmark under Chapter 161 of the Codified Ordinances of Cleveland, Ohio, 1976.

Section 2. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
