AN EMERGENCY ORDINANCE

Authorizing the Director of Port Control to enter into a Lease Agreement with MRK Aviation for the lease of certain space in Building No. 217 located at 6000 North Cargo Road at Cleveland Hopkins International Airport for the purpose of conducting air cargo operations and other support services for various tenants at the airport, for the Department of Port Control, for a period of one year, with four one-year options to renew, the second of which shall require additional legislative authority.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

That the Director of Port Control is authorized to enter into a Lease Section 1. Agreement ("Lease") with MRK Aviation ("Lessee") for use and occupancy of approximately 11,025 square feet of space in Building No. 217 located at 6000 North Cargo Road at Cleveland Hopkins International Airport ("Leased Premises") for the purpose of conducting air cargo operations and other support services for various tenants at the airport. The term of the Lease shall be for a oneyear period, with four one-year options to renew. The first of the one-year options to renew may be exercised by the Director of Port Control, without the necessity of obtaining additional authority of this Council. The second of the one-year options to renew may not be exercised without additional legislative authority. If such additional legislative authority is granted and the second of the one-year options to renew is exercised, then the third and fourth of the one-year options to renew may be exercised at the option of the Director of Port Control, without the necessity of obtaining additional authority of this Council. For use of the Leased Premises during the initial period, Lessee shall pay the City an annual rate of \$24,806.25, payable in monthly installments of \$2,067.19, which is based on an independent thirdparty appraisal. For each option term exercised, the rental rate shall be adjusted based on the United States Department of Labor, Consumer Price Index: "All Urban Consumers" Cleveland and Akron, OH; however not lower than the rate during the initial term, payable in monthly installments.

<u>Section 2.</u> That the Lease authorized shall be prepared by the Director of Law.

<u>Section 3.</u> That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
