EXECUTIVE SUMMARY

The Department of Port Control is requesting authority to exercise the first options to renew various contracts for the requirements for services and materials necessary to maintain repair vehicles, trucks, and various types of equipment, including labor and installation, for the Department of Port Control.

Background/Purpose:

On April 27, 2015 the Cleveland City Council adopted Ordinance No. 225-15 authorizing the purchase by one or more requirement contracts of the necessary items of various types of parts necessary to repair and maintain vehicles, trucks and various types of equipment, including labor and installation, if necessary, for the various Divisions of the Cleveland Hopkins International Airport and Burke Lakefront Airport, Department of Port Control ("Department"). At various times between February and November 2016 the Department entered into a series of requirement contracts with Medina Tractor Sales Company, Jack Doheny Supplies, Inc., Lakefront Automotive Parts, Inc., Concord Road Equipment Mfg., Inc., Murphy Tractor & Equipment, United Rotary Brush, M-B Companies, Inc. and Best Equipment Company, City Contract Nos. RC2016*011, RC2016*010, RC2016*012, RC2016*008, RC2016*078, RC2016*082, RC2016*102 and RC2016*101, respectively, for a period of two years with two one-year options to renew for these services.

Ordinance No. 225-15 provides that the first of the one-year options to renew shall not be exercised without additional legislative authority. The Department is desirous of exercising the first of the one-year options.

Scope of Work:

To provide for the purchase of parts and labor to supply automotive parts for the repair and maintenance of the various vehicles that assist in the operation of the various divisions of the Department of Port Control.

Justification/Urgency:

The current contracts for these services will expire at various times between February and November 2018.
