The Cleveland Division of Fire protects 390,000 people and 83 square miles. Through mutual aid agreements and regional collaboration we are engaged to respond beyond our borders. The 2016 population of the Cleveland Metropolitan Statistical Area is 2,055,612. This encompasses the following counties: Cuyahoga, Geauga, Lake, Lorain, and Medina. In the City of Cleveland, there are several thousand commercial and industrial businesses, approximately 234 schools, and dozens of public institutions including the community; s most critical infrastructures: Cleveland Hopkins International Airport, Rock and Roll Hall of Fame, First Energy Stadium, Quicken Loans Arena, Progressive Field, Tower City and the Horseshoe Casino, the Cleveland Clinic, University Hospital, and the largest theater district outside of New York City (Playhouse Square). These businesses and venues attract thousands of people day and night, year-round. Although the Perry and Davis-Besse nuclear power plants are not in the city, we are located in the evacuation zone in the event of a major incident at either plant. The Division also responds to incidents on the Cuyahoga River and Lake Erie, water treatment facilities, Extremely Hazardous Substances (EHS) facilities and chemical manufacturing facilities in our city and region.

The Cleveland Division of Fire is made up of 761 paid, full-time career firefighters located in the second largest city in the state of Ohio; situated on the southern shore of Lake Erie approximately 60 miles from the Pennsylvania border. In 2016 the Division responded to 70,356 alarms, providing 114,325 apparatus responses, including 11,475 fire responses.

The Division is comprised of 23 Engines, 11 Hook and Ladders, and two Heavy Rescue Squads that provide emergency fire and rescue response and emergency medical services to the community. As outlined in NFPA 1710 (Section 5.2.4.2¿Initial Full Alarm Assignment Capability) all suppression companies operate with a minimum of four

members. The Division has five Battalion Chiefs and one Assistant Chief on a 24-hour duty schedule, and a fullystaffed hazardous material team. These resources are housed in 26 fire stations. The Division also runs a full-time chartered fire training academy.

Since 2003 the Division has been reduced in both personnel (23%) and daily responding companies (20%) which has taxed an already aging fleet and department. Despite the challenges currently faced by the Division the Insurance Services Office (ISO) upgraded the Cleveland Fire Department from a class three Public Protection Classification to a class two in 2017, based largely on efforts to increase training.

The Division of Fire received an annual 2016 budget from the City of Cleveland that is made up of 96% wage and benefits and slightly less than 4% for discretionary spending on day to day supplies. Cleveland's median household income (2008-2012) is \$26,550, almost half that of the median household income for the state of Ohio. The U.S.

Census Bureau currently puts greater than 34% of the city's population below the poverty level. Cleveland's population continues to decline, losing 16% in the last 10 years, and the city is still struggling to rebound from the unusually high number of foreclosures due to the results of the predatory lending crisis. A recent Department of Justice consent decree has forced the city to increase spending on Police training and equipment, limiting the funds available to other city Divisions such as the Division of Fire. The City's current financial situation is not capable of supporting the funding of the projects that we are proposing in this application.

HOODS: We are requesting AFG funding to purchase structural firefighting hoods. The objective of this project is to provide protection from carcinogenic substances that our current hoods cannot provide. These hoods are designed with barrier protection to reduce firefighter exposure to carcinogenic substances. Our Department requires 761 hoods, which will allow for each suppression member to have one in his/her possession with the remaining hoods distributed throughout the Division on battalion commanders' apparatus to be deployed at fire scenes. The hoods will have the following features:

- Flame resistant
- 2 layer construction for excellent protection
- Full drape bid & notched shoulders
- Adaptive face opening
- Blocks 99.9% of particles
- Moderate weight for thermal protection
- Breathable heat blocking fabric
- Maintain performance after laundering
- Certification: NFPA 1971

The equipment will be implemented as a hood exchange program. At the fire scene, the incident Commander will initiate the hood exchange via a radio communication over the fire ground tactical channel. The on-scene Accountability Officer will retrieve two color-coded sealed containers (one with clean hoods and one for contaminated hoods) from the battalion commander's vehicle and coordinate the exchange. Upon completion of fire scene activities or assignment to rehab, the member will report to the designated location to exchange their hood. This will ensure the member always has a clean, contaminant-free hood for each incident rather than using contaminated equipment until returning to station for cleaning. The contaminated hoods will be delivered to the Quartermaster who, in a controlled setting, will utilize an extractor to launder, inspect and then redistribute the hoods to battalion commanders. We intend to use the AFG funding to provide the initial allotment of hoods. Local funding will then be used to replace them on an as-needed basis to maintain the program.

The hoods that are being used by Cleveland Firefighters are cloth hoods. They are effective at thermal protection but

do nothing to stop exposure to carcinogenic particles. In the structural firefighter protective clothing system, the hood has been shown to be the "weak link" when it comes to protecting firefighters from carcinogens, and the thin skin covering the neck area allows carcinogenic substances to pass through. Implementation of the District of Columbia's Fire and Emergency Medical Services Employee Presumptive Disability Amendment Act, which treats firefighters who are diagnosed with job-related cancer, is expected to cost \$6.9 million in FY 2017 and \$30.1 million over the FY 2017 through FY 2020 planning period. Compared with the cost of treating cancer, the cost of the hoods is minimal. The benefit of purchasing NFPA compliant structural firefighting hoods is improved health for firefighters and reduction in incidence of cancer in Cleveland firefighters.

SCBA FACE PIECES: The Cleveland Division of Fire is a busy urban fire department, averaging 4 structure fires per 24-hour shift. Members of the Division have always shared face pieces. The face pieces are decontaminated and disinfected regularly, but we have found that since they are used so often, they do not have time to dry between uses. This facilitates the growth of fungus, bacteria and viruses. Currently, the face pieces that we have are in use 365 days per year, so in addition to not having time to dry, they are used often and they break often. The benefit of purchasing individual SCBA face pieces is improved firefighter health and lower repair and replacement costs for face pieces.

HOODS: Currently the Division is using older hoods that do not stop carcinogenic particles from penetrating to the wearer's skin, allowing members to be exposed to these harmful substances. The immediate impact of this project will be stopping the exposure of Cleveland Firefighters to carcinogenic particles in products of combustion. It is well-known that exposure to carcinogens is cumulative. Over their 30-year career, Cleveland firefighters will be exposed countless times to carcinogenic substances. Clearly, the long-term benefit of these hoods will be stopping these repeated and cumulative exposures to carcinogens, potentially protecting Cleveland firefighters from cancer.

SCBA FACE PIECES: Due to the frequency with which the Division uses SCBAs, they are frequently damaged and placed out of service for repair. This places a heavy workload on the SCBA technicians, who spend a lot of time repairing SCBAs, and results in greater repair costs. We expect that the short term effect of deployment of individual face pieces will be less down-time for SCBAs. As a result, the technicians will have more time for rebuilding and maintaining the SCBA refill stations and compressors, which require frequent maintenance. We expect that the long term effect of deployment of individual face pieces will result in better health for firefighters and less time lost due to illness.

We are requesting AFG funding to purchase a fire apparatus driving simulator. The objective of this project is to improve the safety of apparatus operation by offering opportunities to practice defensive driving techniques in a manner that does not place the firefighters or the public at risk.

The Division's financial situation does not allow us to have an adequate number of spare apparatus to use for teaching our new recruits Emergency Vehicle Operations Course (EVOC). The practical (road driving) portion of the EVOC is vitally important to learning safe emergency vehicle operation, and it cannot be replaced by a simulator, but since we have very few spare apparatus to use, the simulator will provide an important tool to mitigate that issue. Currently, when spare apparatus are not available, line companies have to be taken out of service to allow new recruits to experience apparatus operation, further reducing public safety.

More importantly, the simulator will provide apparatus operators the opportunity to practice reacting to scenarios that are impossible to safely re-create in real life, resulting in increased safety for firefighters and the public. For example, apparatus operators will be able to react to an auto making a sudden left turn in front of the fire truck and other such unexpected driving events. There is no way to safely practice these types of events, but they are a common occurrence to which fire apparatus operators must be trained to react.

The simulator will be used to train all of the Division's firefighters on a regular basis, allowing us to comply with several specific chapters of NFPA 1451:

5.2.1: Driver training shall be provided for all members as often as necessary to meet the applicable requirements of this chapter but not less than twice each year.

5.2.2: Annual driver training shall include hands-on exercises using the actual fire and emergency service organization (FESO) that they are expected to drive.

5.3.1: All members shall be trained in and shall exercise the applicable principles of defensive driving techniques under both emergency and non-emergency conditions.

5.3.9: FESOs shall train operators for inclement weather driving conditions, with emphasis on handling of vehicles, particularly where auxiliary braking devices are to be used.

5.3.13: The training program shall include a review and critique of FESO vehicle crash scenarios, both local and national, to serve as an objective learning experience.

In the years 2014 through 2016, the Division was involved in 150 fire apparatus crashes. The Division has hired 103 new recruits in the last 4 years, and will hire 80 more in 2018, representing 25% of the Division. These young firefighters are receiving the minimum required amount of apparatus driver training due to the fact that the Division does not have enough apparatus to allow them more time behind the wheel. This newer generation of firefighters is accustomed to using learning technology, which makes a fire apparatus driving simulator an efficient way to train them. A new pumper costs \$420,000, nearly twice as much as the simulator, and no new apparatus purchases are currently planned for 2018. Ninety-six percent of the Division's budget is allocated to personnel costs, so funds for a simulator are not available. The apparatus driving simulator, in addition to being a much safer way to train firefighters, is also a much more cost effective way to train them. The benefit of purchasing a fire apparatus driving simulator is improved apparatus operation at a lower cost.

The Division will experience an immediate positive effect upon deployment of the fire apparatus driving simulator. New firefighters will start their driver training in the simulator, which is the safest manner to train for both them and the public. Line companies will not have to be taken out of service to allow recruit firefighters to use their apparatus for driver training. All firefighters will benefit from the opportunity to experience multiple high-risk driving scenarios without any risk to themselves or the public. Based on the experience of the Los Angeles FD in 2006 and the New York City
