EXECUTIVE SUMMARY

The Department of Port Control is requesting authority to exercise the first options to renew various contracts for the requirements for purchase of heavy-duty equipment, snow removal equipment, large capacity trucks, and other equipment with operators, for the Department of Port Control.

Background/Purpose:

On July 22, 2015 the Cleveland City Council passed Ordinance No. 848-15 authorizing the purchase by one or more requirement contracts of the necessary items necessary to purchase vehicles, heavy-duty trucks and various types of snow equipment, for the various Divisions of the Cleveland Hopkins International Airport and Burke Lakefront Airport, Department of Port Control. At various times in October 2016 the Department entered into a series of requirement contracts with, Wausau Equipment Company Inc.; Concord Road Equipment Mfg. Inc.; Murphy Tractor & Equipment Co. Inc.; and, M-B Companies, Inc., for a period of two years with two one-year options to renew for these services.

Ordinance No. 848-15 provides that the first of the one-year options to renew shall not be exercised without additional legislative authority. The Department is desirous of exercising the first of the one-year options.

Scope of Work:

To provide for the purchase of heavy duty equipment, snow removal equipment, and snow removal vehicles to assist in the operation of the various divisions of the Department of Port Control.

Justification/Urgency:

The current contracts for these services will expire at various times in October 2018.

Anticipated Cost: N/A

Schedule or Term of Contract:

Two years with two one-year options for renewal. The first of the one year options to renew shall not be exercised without additional legislative authority.
