Request for Legislation

The Department of Public Utilities is requesting that Ordinance No. 691-18 be amended as follows:

- 1. Replace a portion of the Summary Section with the following:
 - Replace "Windstream Lines" with "Windstream Communications, LLC".
- 2. Replace a portion of Section 1 with the following:
 - **Section 1.** Replace "Windstream Lines" with "Windstream Communications, LLC".

Background/Purpose:

To provide service connectivity to locations outside of Cuyahoga County which are beyond the AT&T service area. The service includes primary and backup communications for SCADA control, security cameras, AMR collectors, and telephones at multiple locations.

Scope of Work/Commodities/Services:

To enter into a contract with Windstream to pay monthly invoices for our current services and any additional services as needed.

Justification/Urgency:

Windstream provides connectivity to locations that are outside of the AT&T service area. This connectivity is critical to the security and safety to our Water system. This services our outlying water towers, pump stations, and facilities. DPU wishes to continue these services.
