AN EMERGENCY ORDINANCE

Amending the Title and Sections 1 and 2 of Ordinance No. 1476-18, passed December 3, 2018 as it pertains to authorizing the Director of the Department of Community Development to enter into agreement with the Cleveland Restoration Society for the Heritage Home Program through the use of Wards 2, 3, 4, 5, 6, 7, 8, 10, 11, 13, 15 and 17 Casino Revenue Funds.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Title and Sections 1 and 2 of Ordinance No. 1476-18, passed December 3, 2018 are hereby amended to read as follows:

An emergency ordinance authorizing the Director of the Department of Community

Development to enter into agreement with the Cleveland Restoration Society for the

Heritage Home Program through the use of Wards 2, 3, 4, 5, 6, 7, 8, 10, 11, 13, 15 and

17 Casino Revenue Funds.

Section 1. That the Director of the Department of Community Development is hereby authorized to enter into agreement effective July 1, 2018 with the Cleveland Restoration Society for the Heritage Home Program for the public purpose of providing housing rehabilitation services to residents residing in the city of Cleveland through the use of Wards 2, 3, 4, 5, 6, 7, 8, 10, 11, 13, 15 and 17 Casino Revenue Funds.

Section 2. That the cost of said contract shall be in an amount not to exceed <u>\$85,500</u> and shall be paid from Fund No. 10 SF 188.

Section 2. That the Title and Sections 1 and 2 of Ordinance No. 1476-18, passed December 3, 2018 are hereby repealed.

Section 3. That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
