The purpose of this letter is to apprise your office that Falbo Group LLC and the Cuyahoga Metropolitan Housing Authority plan to be the general partners of a residential rental development located in or within a one-half mile radius of your political jurisdiction, and will submit an application to utilize the multifamily funding programs of the Ohio Housing Finance Agency (OHFA) for the development of this property.
