usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That Section 53 of Ordinance No. 323-15, passed March 30, 2015,

as amended by Ordinance No. 1473-18, passed January 28, 2019, is amended to read

as follows:

Section 53. Clerk of Court Employees
