#### **AN EMERGENCY ORDINANCE**

WHEREAS, the Wyland Foundation has indicated a desire to make a gift of restoration of the Wyland Whale Wall mural entitled "Song of Whales" located on the Cleveland Public Power Building at 5251 North Marginal Road, valued in the estimated amount of \$44,000, to the Division of Cleveland Public Power, Department of Public Utilities; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Public Utilities is authorized to enter into one or more agreements with the Wyland Foundation to accept the gift of restoration of the Wyland Whale Wall mural entitled "Song of Whales" located on the Cleveland Public Power Building at 5251 North Marginal Road, valued in the estimated amount of \$44,000, for the Division of Cleveland Public Power, Department of Public Utilities. The agreement shall be prepared by the Director of Law and shall contain additional terms and conditions as are required to protect the interests of the City.

<u>Section 2.</u> That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
