Notice of Filing to Establish New Rate Recovery Mechanism  
PUCO Case No. 19-0468-GA-ALT

Dear Public Official:

The East Ohio Gas Company d/b/a Dominion Energy Ohio (Dominion) has continued to invest in infrastructure and other assets that benefit both our customers and our communities. One of these initiatives is called the Capital Expenditure Program. Since 2012, the Public Utilities Commission of Ohio (PUCO) has authorized Dominion to defer certain expenses associated with capital expenditures to expand, improve or replace its facilities to serve customers; to install, upgrade or replace information technology systems; and to comply with rules, regulations, or orders of the PUCO or other governmental entities. These investments have been possible without an adjustment in rates due to Dominion's ability to defer related post-in-service carrying costs, depreciation and property taxes.

On or after April 29, 2019, Dominion plans to file an application asking the PUCO to establish the Capital Expenditure Program Rider (CEP Rider). The CEP Rider will recover both the deferred expenses and ongoing costs related to the assets to which these expenses are attributable. As required by the PUCO, Dominion has submitted a pre-filing notice of its intent to make this application along with other required information. No charge will be implemented until the PUCO has analyzed and audited the schedules contained in the April filing and approves charges based on its review. That process is not expected to be completed until the fourth quarter of 2019.

Dominion has estimated the levels of the CEP Rider based upon an allocation of the estimated program costs, consistent with allocations approved by the PUCO in Dominion's most recent rate case proceeding, PUCO Case No. 07-0829-GA-AIR.


