Local Office on Minority Health Executive Summary

Background/Purpose:

The legislation authorizes the Director of Public Health to apply for and accept a grant from the Ohio Commission on Minority Health (OCMH) for the continuation of the Cleveland Office on Minority Health.

The OCMH announced the availability of funds to support grants for the continuation of local offices in Cleveland, Columbus, Dayton, Summit County, Toledo and Youngstown. Each local office must be established in local health departments. Funding eligibility is limited to City/Combined Health Districts. The Commission accepts one applicant per city.

Mission:

The Cleveland Office of Minority Health (COMH) is a project of the Ohio Commission on Minority Health was established by City ordinance in 2007 and is dedicated to eliminating disparities through innovative strategies focusing on:

- Monitoring and reporting the health status of minority populations
- Informing, educating, and empowering people
- Mobilizing community partnerships and actions
- Developing policies and plans to support health efforts

The purpose of the office is to assist in reducing health disparities among minority populations by working with public and private to improve the effectiveness of our collective impact to address issues identified in the Cleveland Department of Public Health agenda. The local office will continue to work with Healthy Cleveland and other programs within the Department of Public Health to monitor and report on minority health issues.
