WHEREAS, this Council is satisfied that there is good cause to vacate a portion of West 4<sup>th</sup> Street and Mahoning Avenue, as described; and

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That this Council declares its intent to vacate a portion of the

following described real property:

Situated in the City of Cleveland, County of Cuyahoga and State of Ohio and known as being part of Original Brooklyn Township Lot No. 87, further described as follows:

#### West 4<sup>th</sup> Street

Being all that portion of West 4<sup>th</sup> Street (50.00 feet wide) extending from the Northerly line of Mahoning Avenue S.E. (50.00 feet wide) to the Northerly line of Cuyahoga Avenue S.E. (60.00 feet wide).

#### Mahoning Avenue

Being all that portion of Mahoning Avenue S.E. (50.00 feet wide) extending from the Westerly line of West 3<sup>rd</sup> Street (70.00 feet wide) westerly to that portion of Mahoning Avenue S.E. vacated by City of Cleveland Ordinance 2225-41 passed February 9, 1942.

Legal Description approved by Greg Esber, Section Chief, Plats, Surveys and House Numbering Section.

<u>Section 2.</u> That this resolution is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its adoption and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
