### **AN EMERGENCY ORDINANCE**

Authorizing the Director of Economic
Development to enter into a forgivable loan
agreement with Jennings Freeway Industrial
Park, an Ohio general partnership or its
designee, to provide economic development
assistance to partially finance the development of
a build-to-suit facility at the Strike Force Project
site located at 4781 Hinckley Industrial Parkway,
and other associated costs necessary to
redevelop the property.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

#### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Economic Development is authorized to enter a forgivable loan agreement with Jennings Freeway Industrial Park, an Ohio general partnership or its designee, in an amount of \$500,000, to partially finance the development of a build-to-suit facility at the Strike Force Project site located at 4781 Hinckley Industrial Parkway, and other associated costs necessary to redevelop the property.

- Section 2. That the summary for the loan, File No. 713-2019-A, made a part of this ordinance as if fully rewritten, is approved in all respects and shall not be changed without additional legislative authority.
- Section 3. That the Director of Economic Development is authorized to accept such collateral as the director determines is sufficient in order to secure repayment of the loan.
- Section 4. That the Director of Economic Development is authorized to accept monies in repayment of the loan and to deposit the monies in Fund Nos. 17 SF 006.
- <u>Section 5.</u> That the Director of Economic Development is authorized to charge and accept fees in an amount not to exceed the maximum allowable fees under federal regulations and the fees are appropriated to cover costs incurred in the preparation of

the loan application, closing and servicing of the loan. The fees shall be deposited to

and expended from Fund No. 17 SF 305, Loan Fees Fund.

Section 6. That the contract and other appropriate documents needed to

complete the transaction authorized by this legislation shall be prepared by the Director

of Law.

Section 7. That the costs of any funding under this ordinance shall not exceed

\$500,000, and shall be paid from Fund Nos. 17 SF 008, RQS 9501, RL 2019-63.

Section 8. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to

Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest

period allowed by law.
