#### AN ORDINANCE

Establishing the Puritas Avenue Design Review District along mostly commercial properties north and south of Puritas Avenue between West 160th Street and West 137th Street, as shown on the attached map (MC 2606).

Whereas, Councilman Kazy has submitted a require to the City Planning Commission for the establishment of the Puritas Avenue Design Review District in accordance with the procedures outlined in Chapter 341 of the Codified Ordinances of the City of Cleveland;

And;

Whereas, the City Planning Commission has determined that the proposed Puritas Avenue Design Review District meets the criteria for designation outlined in Section 341.04 of Chapter 341 of the Codified Ordinances of the City of Cleveland, Ohio, now therefore

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

**Section 1.** That the Puritas Avenue Design Review District is hereby established and includes lands located on the south side of Puritas Avenue between the centerline of West 160<sup>th</sup> Street and the northerly prolongation of the easterly line of a parcel of land known as being the southerly 120 feet of Sub Lot No. 42 in the Scott-Hall-Clark Subdivision No. 2, of part of Original Rockport Township Section No. 1 as shown by the recorded plat in Volume 43 of Maps, Page 23 of Cuyahoga County Records (PPN 02319010);

And;

That the Puritas Avenue Design Review District is hereby established and includes lands located on the north side of Puritas Avenue between the centerline of West 155<sup>th</sup> Street and the centerline of West 137<sup>th</sup> Street (south of Bellaire Road) as shown on the attached map;


