AN EMERGENCY ORDINANCE

Authorizing the Director of Public Works to enter into a grant agreement with the Cleveland Cultural Gardens Federation, or its designee, to provide financial assistance needed for the Centennial Peace Plaza in Rockefeller Park.

WHEREAS, upon its completion, the Centennial Peace Plaza located in the Cultural Gardens, will be a central gathering place for arts and cultural events with diverse, multicultural music, dance, educational, and cultural offerings on a regular basis; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Public Works is authorized to enter into a grant agreement with the Cleveland Cultural Gardens Federation, or its designee, to provide financial assistance in the amount of \$75,000 for the design of, and project management services for, the Centennial Peace Plaza in Rockefeller Park.

Section 2. That the Director of Law is authorized to prepare the grant agreement and other documents that may be appropriate to complete the transaction.

Section 3. That the costs of the agreement shall not exceed \$75,000 and shall be paid from Fund No. 11 SF 006, RQS 7001, RL 2020-2.

Section 4. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
