Request for Legislation

An ordinance authorizing one or more public improvement and public improvement by requirement contracts for the divisions of the Department of Public Utilities for various improvements of civil, mechanical, electrical, site, and building systems, including but not limited to, replacement, repair, and modification of indoor and outdoor building systems, including roofs, with all related work; and authorizing the Director to employ one or more professional consultants to design the improvements, for a period up to two years.

Background/Purpose:

Various facilities and buildings of the Department of Public Utilities (DPU) need general upgrades to accommodate the employees and customers who frequent the facilities and buildings.

Scope of Work/Commodities/Services:

Public improvement projects for the divisions of DPU for various improvements of the civil, mechanical, electrical, site, and building systems, including but not limited to, indoor and outdoor building systems, roofs, and authorizing the Director to employ one or more professional consultants to design the improvements, and authorizing the Director to employ one or more professional consultants to design the improvements, for a period up to two years with all related work.

Justification/Urgency:

There are current safety and liability issues that need to be addressed in the current year and next year, including roof work at some facilities.

Anticipated Costs and funding source:

CWD - \$2,000,000.00, CPP - \$70,000.00, WPC - \$200,000.00

The Department of Public Utilities is only funding the initial expenditures at this time. The cost of all contracts and other expenditures authorized shall be paid from Fund Nos. 50 SF 002, 52 SF 001, 54 SF 001, 54 SF 400, 58 SF 001, and from the fund or sub-funds which are credited the proceeds of the sale of future revenue bonds issued for this purpose and language for grants including NEORSD Community Cost Share.

Schedule or Term of Contract:

Legislation is to lead to one or more public improvement and /or public improvement by requirement contracts for terms of up to two (2) years for construction.
