EXECUTIVE SUMMARY OF TENTATIVE AGREEMENT

March 17, 2020

1. WAGES – ARTICLE XXIII

Retroactive to April 1, 2019 2.0% wage increase Effective April 1, 2020 2.0% wage increase Effective April 1, 2021 2.0% wage increase

2. INSURANCE – ARTICLE XVI

Current contract on benefits to be maintained except:

 Modify life insurance coverage effective April 1, 2020 from \$15,000 to \$25,000; and

• Modify dental and vision benefits effective April 1, 2020 as follows:

Dental: Reduce Deductible to \$25 per person and \$50 per family (from \$50 per

person and \$150 per family)

Increase Basic Coinsurance to 90% (from 80%)

Increase Orthodontia Lifetime Maximum to \$2,000 (from \$1,500)

Increase Annual Maximum to \$2,000 (from \$1,000)

Vision: Increase Frame Allowance to \$150 (from \$120)

Reduce UV copay to \$0 (from \$10)

Increase Eye Exam Frequency to once every 12 months (from once

every 24 months for member aged 20 or over)

3. <u>UNION DUES – ARTICLE III</u>

Delete references to "Fair Share Fee."

4. <u>FIRE DISPATCH CENTER – SIDE LETTER</u>

Establish terms for Fire-Dispatchers working 12-hour shifts as follows:

- Wages Hourly rate based on salary divided by 2080
- Holidays Employees to receive eight (8) hours of banked time for each holiday and periodic holiday payment
- Family Days Three (3) priority days (currently 2) to be used from employee's accrued compensatory time
- Hours of Work Overtime for all hours worked in excess of twelve (12) per day and forty (40) per week
- Shift Differential \$0.35/hour for employees working late shift
- Breaks One (1) 45-minute lunch break and two (2) 15-minute breaks per 12-hour shift
- Pending Grievances Union to withdraw with prejudice

5. FIRE INVESTIGATION UNIT ("FIU") – ARTICLE VIII

Expand City's training flexibility of employees graduating from Police Academy into the FIU to allow for both office and field training.

6. UNIFORM ALLOWANCE – ARTICLE XIX

- Increase maintenance allowance by fifty dollars (\$50.00) (from \$600 to \$650 effective in 2020)
- Increase one-time promotional allowance (currently \$150.00) to following amounts effective in 2020:

-	Firefighter to Lieutenant	\$400
	Lieutenant to Captain	\$250
_	Captain to Battalion Chief	\$250
_	Battalion Chief to Assistant Chief	\$250
