### **AN EMERGENCY ORDINANCE**

Amending Section 1 of Ordinance No. 201-2020 passed February 10, 2020 as it pertains to authorizing the Director of the Department of Community Development to enter into an agreement with the Broadway School of Music and Arts for the Community Arts Instruction and Enrichment Program through the use of Wards 2, 3, 4, 5. 6, 7, 8, 9, 12, 13, 14, 15, 16 and 17 Casino Revenue Funds.

## BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

**Section 1.** That Section 1 of Ordinance No. 201-2020 passed February 10, 2020 is hereby amended to read as follows:

Section 1. That the Director of the Department of Community Development is authorized to enter into an agreement effective January 1, 2019 February 1, 2018 with the Broadway School of Music and Arts for the Community Arts Instruction and Enrichment Program for the public purpose of providing music education to low and moderate income students residing in the city of Cleveland through the use of Wards 2, 3, 4, 5, 6, 7, 8, 9, 12, 13, 14, 15, 16 and 17 Casino Revenue Funds.

**Section 2.** That Section 1 of Ordinance No. 201-2020 passed February 10, 2020 is hereby repealed.

**Section 3.** That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
