Goals for Shared Mobility in Cleveland

- Increase mobility options and ridership for all residents;
- Manage public space to ensure continued safe and shared use of the public right of way;
- Promote equity in transportation access across the city;
- Promote health, safety, and public welfare by advancing Vision Zero goals;
- Establish a regulatory and evaluation structure that can adapt to meet the needs of residents, especially as technology evolves;
- Contribute to improved quality of life in the City of Cleveland by strengthening our neighborhoods, delivering superior services, embracing the diversity of our citizens, and making Cleveland a desirable, safe city in which to live, work, raise a family, shop, study, play and grow old.

Shared Mobility Basics

- E-scooters, e-bikes, and pedal bikes for rent for short distance travel
- Devices are dockless—they lock to themselves
- Devices are traceable through integrated GPS
- Users access the system through smartphone apps











Timeline Review

- June 2019—shared mobility permitting legislation passed
- Fall-Winter—six month demonstration period with five operators
- March 2020—COVID-19 system shutdown
- June 2020—legislation renewal; relaunch with COVID protocols







Cleveland Ridership

- 213,199 rides
- 207,730 miles
- 2.5 million minutes
- 0.99 mile average trip
- 11:50 average duration












Popular Routes

Economic Impact

- \$34,000 in the Shared **Mobility Fund**
- Employment impact to date
 - 46 full time positions
 - 3 part time positions
 - 218 independent contractors
- \$300,000 in wages paid to date









Public Feedback

- Top requests: longer hours & more bike lanes
- Top issues: sidewalk riding & poor parking

"I love seeing individuals riding them to and from work in the early hours; hate seeing scooters "dumped" on the sidewalk. Not fond of jumping out of the way when they are recklessly driven on the sidewalks; love seeing visitors to the City have an option for urban travel other than cars, Ubers, etc."









Ranked Operator Feedback

- 1. Expand hours of operation
- 2. Increase fleet sizes
- 3. Increase speed cap to 15 mph
- 4. Refine special events geofencing approach
- 5. Issue annual permits
- 6. Increase deployment locations
- 7. Reduce number of vendors









Administrative Rules & Regulations: Updates

- COVID-19 protocols
 - Compliance with federal, state, and local guidance
 - Device sanitization
 - Rider messaging



- Operating hours permitted from 5:00am to 9:00pm until Labor Day
- Phased requirement for information accessibility for visually impaired







Legislative Requests

- Minor language updates to clean up code
- Elimination of e-scooter speed limit from traffic code
- Additional permitting authority to:
 - Extend permit term for current vendors through next Spring
 - Establish a permitting schedule beginning in 2021
 - Establish permittee fines for violations
 - Apply for and accept programmatic grants and contributions for the Shared Mobility Fund







Anticipated Next Steps

- Finalize timeline for relaunch
- Public communication
- Focus areas:
 - Organize device parking
 - Reduce sidewalk riding
 - Reevaluate 12 mph speed cap
 - Plan for geographic expansion
 - Survey riders
