**Grantor:** The Alcohol, Drug Addiction and Mental Health Services Board of Cuyahoga County (“ADAMHS Board”)

**Program Name:** Specialized Docket Subsidy, 2020-2021

**Description:** This proposed project is submitted by the Cleveland Municipal Court (CMC) to expand access to evidence-based supervision and treatment services for defendants of the four (4) Court Specialized Dockets: The Greater Cleveland Drug Court, Mental Health Docket, Veterans Treatment Docket, and Human Trafficking Specialized Docket. The goal is to reduce recidivism and substance abuse among high-risk participants. The Grant is retroactive to July 1, 2020.

**Grant Period:** July 1, 2020 to June 30, 2021

**Grant Amount:** \$180,000
