Section 1. That objection to the transfer of ownership of a C2 and C2X Liquor Permit to IYS Ventures, LLC, 4901 Fleet Avenue, Cleveland, Ohio 44105, Permit No. 41545920030 be and the same is hereby withdrawn and Resolution No. 129-2020, containing such objection, be and the same is hereby repealed and that this Council consents to the immediate permit thereof.

<u>Section 2</u>. That this resolution is hereby declared to be an emergency measure and provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its adoption and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
