# **Ordinance No. 686-2020**

AN EMERGENCY ORDINANCE

To amend Section 50 of Ordinance No. 323-15, passed March 30, 2015, as amended, relating to compensation for various classifications.

FOR PASSAGE August 26, 2020

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That Section 50 of Ordinance No. 323-15, passed March30, 2015, as amended by Ordinance No. 151-16, passed February 29, 2016, Ordinance No. 1343-16, passed November 21, 2016, Ordinance No. 951-17, passed September 18, 2017, Ordinance No. 171-2019, passed February 11, 2019, and Ordinance No. 454-2020, passed June 3, 2020, is amended to read as follows:

#### Section 50. Hourly Rate - MCEO

Effective May 1, 2020, compensation for all persons employed by the hour in any of the following classifications shall be fixed by the appointing authority within the limits established in the following schedule for each classification:

		<u>Minimum</u>	<u>Maximum</u>
1	Construction Equipment - Group A	46.03	<del>57.54</del> <u>57.59</u>
2	Construction Equipment - Group B	45.91	<del>57.39</del> <u>57.44</u>
3	Master Mechanic	46.83	<del>58.54</del> <u>58.59</u>

Section 2. That existing Section 50 of Ordinance No. 323-15, passed March30, 2015, as amended by Ordinance No. 151-16, passed February 29, 2016, Ordinance No. 1343-16, passed November 21, 2016, Ordinance No. 951-17, passed September 18, 2017, Ordinance No. 171-2019, passed February 11, 2019, and Ordinance No. 454-2020, passed June 3, 2020, is repealed.

Section 3. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
