Request for Legislation

An emergency ordinance authorizing the Director of Public Utilities to enter into one or more contracts with OPEX Corporation for professional services necessary to provide hardware and software support and maintenance for mail extractors, scanners, and ID assist tower, for a period of two years.

Background/Purpose:

The Department of Public Utilities, Division of Fiscal Control (UFC) is requesting legislation to authorize the purchase of the renewal of On-Call Maintenance Services Agreement for proprietary equipment. UFC will utilize a direct award contract with OPEX Corporation (OPEX) to provide the necessary maintance and service of the equipment. UFC has utilized OPEX mail opening equipment and On-Call Maintance for more than 30 years.

UFC currently utilizies six OPEX mail opening/extracting machines and scanners to open and image all Water, Water Pollution Control, Sewer and CPP payments. All six opener/extractor and scanners were purchased from OPEX and installed by OPEX.

Scope of Work/Commodities/Services:

The direct award contract with OPEX is needed to maintain our current:

- 6 Falcon Based Machines.
- 2. 6 Model 72 Base Machine,
- 3. Falcon MICR and Annual License Fee,
- 4. Falcon Multislot ID Assist Tower.
- 5. Insight Software Annual License Fee,
- 6. Insight Falcon Scanner Stats Annual

Justification/Urgency:

UFC is requesting legislation to purchase the On-Call Maintenance Service Agreement from January 1, 2021 to December 31, 2022 through OPEX Corporation.

OPEX Corporation is the authorized sole source provider for maintaining OPEX equipment. There are no other authorized dealers available to provide service/maintenance due to proprietary diagnostic software covered by various patents and copyrights.

The reliability of the equipment is the utmost importance in our daily operation to insure our operation will not be down for any significant period of time. The one stop processing, the onsite customer support, and the working relationship between OPEX and BancTec will assure that the efficiencies, accurate application of payments and the integrity of the documents are processed and handled in timely manner and in compliance with our policies.
